- 1. Award of Contract to Hot Line Construction, Inc. – for the Underground Overhead Facilities along East Sherwood Avenue between Browning and Wiley Streets.**

The construction project is fully funded with Disaster Recovery Initiative grant fund.

The Inspector opened sealed bids for this project on April 2, 2015, at 2:15 p.m. The six bids received were as follows:

Line Item #1 of Hot Line Construction, Inc. bid schedule contained an arithmetic error. Their bid schedule total was \$121,750.00, but after correcting the arithmetic error, the bid total was \$120,588.00.
