Project Description: The McFarland Planning and Building Department have conducted a study with Willdan Financial to provide the most updated Development Impact Fees based on the items the City of McFarland plans in the future for the next 20 years and existing City properties/facilities. The City's Development Impact Fees have not be updated within the last 10 years.
